WHAT IS IGRS?

IGRS is an ICT platform managed by the Ministry of Labour and Foreign Employment, Sri Lanka Bureau of Foreign Employment (SLBFE), in coordination with the International Organization for migration (IOM) to provide end-to-end assistance and guidance to aspiring migrant workers.

OUR AIM

Our aim is to empower aspiring migrant workers with the relevant skills and competencies required for foreign employment and facilitate connecting them with potential foreign employers and Licensed Foreign Employment Agents. Thus, creating a skilled pool of Sri Lankan Migrant Workers with proven qualifications for the international labour market.

FOR WHOM?

First phase of IGRS provides assistance to the Sri Lankan public sector employees who are willing to pursue foreign employment.

The second phase of IGRS will be open to all Sri Lankans or are willing to pursue foreign employment in a safe, secure and orderly manner.

IGRS also caters to the Licensed Foreign Employment Agents (LFEAs) by giving them access to the Foreign Employment Ready Database (FERD). The FERD encompasses the skilled pool of Sri Lankan aspiring migrant workers.



IGRS PROCESS

01.

Register with IGRS:

Fill in the online Registration Form and submit.

02.

Screening and Referral :

The Career Advisory Officers with the assistance of Career Advisory Experts will review each application to determine the registered applicants' suitability for foreign employment. The Career Advisory Expert in consultation with the registered applicant will prepare a career action plan for foreign employment.

03.

Inclusion in Foreign Employment Ready Database (FERD):

Profiles of the registered applicants who have successfully acquired the minimum skills and experience required for the chosen occupation will be added to the Foreign Employment Ready Database (FERD) by Career Advisory Officers/ Career Advisory Experts.

04.

Connect:

Once added to the FERD, qualified applicants have the opportunity to link with potential foreign employers and Licensed Foreign Employment Agents.

Securing foreign employment entirely lies between the applicant and the foreign employer/ the Licensed Foreign Employment Agent.
